# Important Notice for Applicants Eligibility Conditions

## 1. Are you or your parent or guardian a member of a Local Aboriginal Land Council?

Applicant students **MUST** be a member of a Local Aboriginal Land Council to be eligible for a NSWALC Education Endowment Scholarships.

- a. Where the applicant is under 18 the Parent/s or legal guardian/s of the Applicant must be member/s of a Local Aboriginal Land Council.
- b. Applicants 18 years of age and over must (themselves) be a member of a Local Aboriginal Land Council.

Applicants **MUST** provide evidence of Land Council membership with the application.

## 2. Do you, or will you, receive Abstudy or any other scholarship for your studies?

Applicants are to provide full details of all school fees and related expenses paid or claimable by Abstudy or any other scholarship or funding program.

Applicants entitled to or in receipt of Abstudy or other funding will be individually assessed against their total school fees and related expenses to determine the level of support available to them under the NSWALC Education Endowment Fund.

## 3. Are you a tertiary student undertaking a first degree or diploma or certificate at an approved educational institution?

NSWALC Endowment Scholarships are only available for students undertaking a first degree (undergraduate) Scholarship and are **NOT** available for Masters OR Doctorate studies.

Courses at approved Interstate educational facilities are acceptable; however, funding for overseas travel or study is **NOT** available.

## 4. How will payment of the Education Endowment Scholarship be made?

All Applications for a NSWALC Education Endowment Scholarship are to be made by the individual applicant or their parent or guardian.

All payments are subsequently made directly to the institution where you are studying and/or approved suppliers.

## 5. How much can you apply for under the NSWALC Education Endowment Fund Scholarship?

Certain caps are in place in relation to the scholarships available under the NSWALC Education Endowment Fund. All applicants for funding will be individually assessed based on the information provided by the Applicant in the funding request part of the Applications Form.

Funding is strictly limited and grants are made based on criteria set by NSWALC.

The decision on education grants is final and no reviews or appeals will be accepted.
